The Club maintains member files in a confidential manner. The Club has permission to discuss and exchange information regarding my child's academic performance and progress with the school my child attends, as well as with the Office of Juvenile Affairs, their counselor, case manager, or any other provider, as applicable.
Membership assessments and pre/post tests are periodically given to members. Information may be shared with Boys & Girls Clubs of America for evaluation purposes.
My child has permission to participate in Club based, on-site mentoring programs that are offered. I understand the
Boys & Girls Club is a program based facility and I am enrolling my child to participate in programs.
I consent to the use of any photos, video, audio recordings or quotes of my child for the positive promotion of the Boys & Girls Club as the Club deems necessary.
In the event of a medical emergency, the Boys & Girls Club may have my child evaluated and treated by a doctor or nearest emergency center. Resonable effort will be made to contact me or someone on my child's emergency contact list first. I will keep my contact information updated at all times.
I understand the Club is a drop in program and not a daycare. I understand that my child can leave the premises at will, and I agree to hold the Club harmless and not responsible for the whereabouts of my child once they check out of our facility. Abuse of this privilege can result in loss of privilege.
I understand that membership dues are non-refundable, and my child's membership must be current in good standing in order for them to attend.
I understand membership is contingent upon my child's physical, mental and emotional maturity and that they must possess the ability to interact independently and responsibly in the Club setting.
The Club discourages bringing valuable items to the Club and will not be held liable for lost, stolen, or broken items.
I understand that I must keep the Club informed of any changes in phone number or address.
I understand that tobacco products of any kind are not allowed on Boys & Girls Club property.
I understand it is my responsibility to know the Club hours of operation, and will be on time to pick up my child. I also
understand that fees will be assessed for late pickups, and can result in suspension from the program until fees are paid in full.
I have read and fully understand the information contained in the application and the contents and agreements made by me, and request that my child's application for membership in the Boys & Girls Club of Bartlesville be accepted.
